### **EXECUTIVE ORDER**

(No. 14 Series of 2021)

AN ORDER ADOPTING THE TRAVEL PROTOCOLS AND OTHER GUIDELINES OF EXECUTIVE ORDER NO. 12 OF THE PROVINCIAL GOVERNOR UNTIL ITS EXTENDED PERIOD OF EFFECTIVITY AND MANDATING ADDITIONAL IMPOSITION AMID THE SURGE IN THE NUMBER OF CONFIRMED COVID-19 CASES IN THE COUNTRY

WHEREAS, Article II, Section 15 of the 1987 Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, in spite of the measures from both the national government, the local government of Oriental Mindoro and the LGU of Bongabong, there has been a sudden and unexpected surge in the number of positive cases of COVID-19 in the country and at the local level in recent weeks;

WHEREAS, with the goal of ensuring that the local people of the municipality are protected health-wise against the virus, there is a need for enhanced measures to control and manage the ingress and egress of travelers to-and-fro the Municipality of Bongabong;

WHEREAS, the Provincial Governor issued Executive Order No. 12 Series of 2021 last March 24<sup>th</sup>, 2021 concerning the movement of people to, from, and passing through Oriental Mindoro to curb further transmission of the virus in the province;

NOW, THEREFORE, I, ELEGIO A. MALALAUAN, O.D., Municipal Mayor of Bongabong, Oriental Mindoro by virtue of the powers vested in me by law, do hereby order the following:

## Section 1. ADOPTING TRAVEL GUIDELINES PRESCRIBED BY EO NO. 12

The Municipality of Bongabong shall adopt and adhere to Executive Order No. 12 issued by the Provincial Governor last March 24<sup>th</sup> 2021 concerning new travel protocols from March 25, 2021 to April 4, 2021 involving:

- Limiting the allowed travel of people to-and-fro the areas from the GCQ Bubble (Metro Manila, Bulacan, Cavite, Rizal, and Laguna), and including the adjacent Province of Occidental Mindoro, to reasons considered as essential travel;
- 2. Travel of tourist to the Province of Oriental Mindoro

#### Section 2. OTHER HEALTH PROTOCOLS

The Municipality of Bongabong shall also adopt the other guidelines prescribed by EO No. 12 with regard to Liquor Ban, Curfew, Mass Gathering, and Religious Activities.

#### Section 3. ADDITIONAL TRAVEL IMPOSITION

- Travelers who falls under the category of Authorized Persons Outside of Residence (APOR) shall be allowed to enter and stay in the Municipality of Bongabong for 24 hours;
- 2. Those APOR who will have to stay longer than 24 hours in Bongabong shall be required to provide a negative result of COVID-19 testing (24-hour validity) upon arrival --- Rapid Antigen Testing will be considered.

#### Section 4. REPEALING CAUSE

All rules and regulations, executive orders, office orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion hereof, are hereby repealed or modified accordingly.

#### Section 5. SEPARABILITY CLAUSE

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

#### Section 6. EFFECTIVITY

This Executive Order shall take effect immediately and shall remain enforced, unless revoked or amended, until the extended period of the effectivity of Executive Order No. 12 of the Provincial Governor. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
