## (No. 15 Series of 2021)

AN ORDER REGULATING THE SCHEDULE OF THE ACCESS OF EACH BARANGAY TO THE PUBLIC MARKET OF BONGABONG TO ENFORCE SOCIAL DISTANCING MEASURES AMID THE COVID-19 THREAT

WHEREAS, the World Health Organization has declared the Coronavirus disease (COVID-19) a global pandemic affecting different nations around the globe with exponential growth on the number of affected individuals;

WHEREAS, with hopes of curbing the rising number of confirmed cases in the country, the Office of the President thru the Executive Secretary issued a memorandum on the stringent social distancing measures and the enhanced community quarantine over the entire Luzon for the management of the COVID-19 situation;

WHEREAS, the Province of Oriental Mindoro, which has yet to have confirmed cases of COVID-19 as of this writing, are also implementing measures adopting the guidelines from the memorandum, and have also previously issued its own Executive Orders against the entry and spread of COVID-19 in the province;

WHEREAS, in adherence to the stringent social distancing and enhanced community quarantine measures, the local government of Bongabong will be regulating the access of the local people to the public market;

**WHEREAS**, the purchasing of food, or its provision, shall remain unhampered, and thus, the public market shall continue to remain open on its regular schedule, but there is a need to limit the number of people inside the market on any given time to avoid congestion;

**NOW, THEREFORE I, ELEGIO A. MALALUAN,** Municipal Mayor of Bongabong, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby promulgate this Order, as follows:

# SECTION 1. REGULATED ACCESS OF BARANGAYS TO THE PUBLIC MARKET OF BONGABONG

In order to ensure that safe social distance is still observed within the premises of the local public market of Bongabong amid the threat of the coronavirus, there shall be a prescribed schedule wherein barangays in Bongabong are permitted to access the public market for the purchase of food and other essentials.

## SECTION 2. SCHEDULE OF ACCESS TO THE PUBLIC MARKET FOR EACH BARANGAY (CLUSTERING)

The five adjacent barangays within the Municipality of Bansud namely, Villa Pagasa, Catmon, Malu, Bato, and Sumagui, shall be allowed to access the public market of Bongabong on Tuesdays and Fridays.

#### **SECTION 3. IDENTIFICATION**

There shall be personnel from the LGU of Bongabong and/or the Municipal Police Station-PNP to verify the place of residence of the individuals who wish to enter the market to purchase goods.

Those without valid identification or travel pass from their respective barangay shall be barred from entering the public market.

#### SECTION 4. PENALTIES

Anyone who will fail to abide by this order shall be meted with the appropriate sanctions and penalties as prescribed by the existing laws, and possible revocation of their barangay travel pass.

#### SECTION 5. REPEALING CAUSE

All rules and regulations, executive orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion thereof, are hereby repealed or modified accordingly.

#### SECTION 6. SEPARABILITY CLAUSE

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

#### SECTION 7. EFFECTIVITY

This Executive Order shall take effect on the 24<sup>th</sup> of April and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
