EXECUTIVE ORDER

(No. 08 Series of 2021)

AN ORDER MANDATING THE TRAVEL PROTOCOLS OF THE MUNICIPALITY OF BONGABONG IN CONSIDERATION OF IATF RESOLUTION 101 ON THE EASING OUT AND MORE UNIFORM TRAVEL PROTOCOLS

WHEREAS, the National Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases approved the uniform travel protocols for land, air, and sea of the Department of the Interior and Local Government, crafted in close coordination with the Union of Local Authorities of the Philippines, League of Provinces of the Philippines, League of Municipalities of the Philippines, and the League of Cities of the Philippines;

WHEREAS, through IATF Resolution No. 101, the Inter-Agency Task Force enjoined the Local Government Units (LGUs) to ensure smooth implementation of the new uniform travel protocols applicable to all LGUs;

WHEREAS, with the goal of opening up the local economy anew and relieve the burden of travelers to-and-fro the Municipality of Bongabong, the LGU shall ensure compliance with the aforementioned IATF Resolution, but with added measures in place as deemed necessary by the Local Chief Executive and Bongabong IATF;

NOW, THEREFORE, I, ELEGIO A. MALALAUAN, O.D., Municipal Mayor of Bongabong, Oriental Mindoro by virtue of the powers vested in me by law, do hereby mandates the implementation of these travel protocols in the Municipality of Bongabong.

Section 1. DOCUMENTARY REQUIREMENTS FOR TRAVELERS

- Travel Authority issued by the Joint Task Force COVID Shield and medical health certificates shall no longer be required;
- All local residents traveling to Bongabong shall only be required to get Barangay Acceptance from their respective barangays;
- Officials and Personnel from National Government Agencies and their attached agencies must provide valid IDs and travel order from their agencies, and must pass symptom-screening at ports of entry and exit;
- 4. There shall no longer be any distinctions --- APOR, LSI, ROF, and Humanitarian --- amongst travelers.

Section 2. REGISTRATION AND CONFIRMATION

- Online registration prior to travel shall still be required thru the link <u>TinyURL.com/BongabongRegister</u>; travelers need to fill out the form with their personal details;
- Upon registration, local residents shall upload their barangay acceptance; and the NGA personnel their valid IDs and travel order from their respective agencies;
- Only those with complete registration shall be given confirmation of travel.
 Travelers are advised to wait for their travel confirmation via text before travelling
 to avoid being stranded or held up at the point of exit (Batangas Port) and point
 of entry (Calapan Port).

Section 3. TESTING AND QUARANTINE

- Travelers shall not be required to undergo testing, such as RT-PCR Test and Rapid Antigen Test, prior to travel or upon arrival unless deemed necessary by the local health office;
- 2. No traveler shall be required to undergo quarantine unless they exhibit symptoms upon arrival at the municipality.

Section 4. MINIMUM PUBLIC HEALTH STANDARDS

- Minimum public health standards, which include physical distancing, hand hygiene, cough etiquette, and wearing of face masks and face shields among others, shall be strictly implemented across all settings; and
- Basic health assessment shall be implemented in the profiling desk of the LGU upon arrival of individuals at the municipality;

Section 5. REPEALING CAUSE

All rules and regulations, executive orders, office orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion hereof, are hereby repealed or modified accordingly.

Section 6. SEPARABILITY CLAUSE

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

Section 7. EFFECTIVITY

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
