EXECUTIVE ORDER  
(No. 42 Series of 2022)

AN ORDER CREATING THE INTER-AGENCY MONITORING TASK FORCE (IMTF)  
FOR CHILD-FRIENDLY LOCAL GOVERNANCE AUDIT (CFLGA) OF THE LOCAL  
GOVERNMENT UNIT OF BONGABONG, ORIENTAL MINDORO

**WHEREAS**, the country’s commitment towards AmBisyon 2040 and Sustainable Development Goals (SDGs) requires collaboration among local government units (LGUs), national government agencies (NGAs), and Civil Society Organizations (CSOs) geared towards the rights of Filipino children;

**WHEREAS**, the Department of the Interior and Local Government, Department of Social Welfare and Development, Department of Education and Department of Health are in support of ensuring the progressive realization of the children’s rights to survival, development, protection, and participation through the Child-Friendly Local Governance Audit (CFLGA), a mandatory audit system implemented since 2014 which assesses the LGU performance in the delivery of social services and programs for child and youth welfare;

**WHEREAS**, Joint Memorandum Circular on the Revised Child-Friendly Local Governance Audit (CFLGA) and Implementation Guideline provide the LGUs and other agencies for guidance in the conduct of CFLGA and ensure their commitment in the audit implementation;

**WHEREAS**, the result of the audit-generated data will serve as the basis for the LGUs and NGAs to identify strengths and opportunities to enhance the rights responsive governance in the country;

**NOW, THEREFORE I, ELEGIO A. MALALUAN**, Municipal Mayor of Bongabong, Oriental Mindoro, by virtue of the powers vested in me by law, do hereby order the organization of the Inter-Agency Monitoring Task Force (IMTF) for Child-Friendly Local Governance Audit (CFLGA) Local Government Unit of Bongabong, Oriental Mindoro;

SECTION 1. COMPOSITION

The Inter-Agency Monitoring Task Force (IMTF) for Child-Friendly Local Governance Audit (CFLGA) shall be composed of the following persons, to wit:

**SECTION 2. FUNCTIONS AND DUTIES**

The Inter-Agency Monitoring Task Force (IMTF) shall have the following functions and duties:

1. The IMTF shall convene the LCPC of the start of CFLGA and provide orientation on the CFLGA Data Capture Form and corresponding data/documentary requirements;
2. Upon receipt of all data requirements, the IMTF Chairperson shall convene the IMTF to accomplish CFLGA DCF;
3. The IMTF Chair shall present the initial results of the audit to the LCPC which will serve as validation exercise and exit conference;
4. Ensure all entries of both forms are consistent and correct;
5. Upon clearance and approval from the LCPC, the CFLGA DCF shall be submitted to Provincial-IMTF including the supporting documents signed by all IMTF members and noted by the LCEs.

**SECTION 3. REPEALING CAUSE**

All rules and regulations, executive orders, memoranda, or any part thereof, previously promulgated in conflict with or contrary to these Executive Order or any portion thereof, are hereby repealed or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE**

If any portion or provision of this Executive Order is declared unconstitutional or invalid, the other portions or provisions hereof, which are not affected thereby shall continue in full force and effect.

**SECTION 5. EFFECTIVITY**

This Executive Order shall take effect immediately and shall remain enforced unless revoked or amended. Let copies of this Order be furnished to all concerned for their information, guidance, and action.
