MUNICIPAL ORDINANCE NO. 2020-09 Series of 2020

AN ORDINANCE PRESCRIBING CITATION TICKET FOR VIOLATION OF MUNICIPAL ORDINANCES AND PRESCRIBING GUIDELINES FOR THE USE THEREOF

BE IT ENACTED BY THE SANGGUNIANG BAYAN IN SESSION ASSEMBLED:

Section 1. Title. This Ordinance shall be known as the Bongabong Citation Ticket Ordinance and shall hereafter be referred to as the Ordinance"";

Section 2. Form of Citation Ticket. There is hereby adopted a form of citation ticket to be used by law enforcers of the municipality in citing individual or entity for violation of applicable municipal Ordinances with penal provision, the form of which is shown below:

Section 3. Applicability. The issuance of the afore-cited citation ticket shall be applicable to all general municipal ordinances prescribing fines as penalty therefor, except for violation of ordinances pertaining to issuance of business permit.

Section 4. Rules and Regulations in the Implementation. Upon the effectivity hereof, the office of the municipal mayor shall formulate rules and regulations for the smooth implementation of this ordinance, which shall include but not limited to the following:

- Issuance of commission to qualified officials or employees of the municipality who are at the frontline of enforcement of municipal ordinances including the authority to confiscate driver's license in case of violation of traffic or parking ordinance and to file the corresponding case in the proper court in case of failure to heed the citation ticket;
- 2. Establishment of qualifications (mental, moral, physical fitness, and qualifying examinations) and continuing training/education for officials and employees tasked to enforce municipal ordinances;
- 3. The validity of the commission shall be one (1) year from issuance thereof and renewable every year thereafter, unless sooner revoked;
- 4. Establishment of data bank for violations of municipal ordinances;
- 5. Designation of personnel tasked to litigate violation of municipal ordinances;
- 6. Establishment of appropriate trust fund for the proceeds of fines for violation of municipal ordinances;
- 7. Provision of privileges to officials and employees tasked to enforce municipal ordinances; and
- 8. Printing of Citation Tickets

Section 5. Training of Officials who can Issue Citation Ticket. To update officials who may issue citation tickets of the applicable penal ordinances of the municipality, series of orientation training shall be conducted in their favor. The mechanics and implementation thereof shall be the responsibility of the Office of the municipal mayor.

Section 6. Repealing Clause. All ordinances which are inconsistent with the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 7. Separability Clause. If any portion or provision of this ordinance is declared unlawful or illegal, the portion or provision not affected thereby shall continue to be in full force and effect.

Section 8. Effectivity Clause. This Ordinance shall take effect upon its approval and compliance with the posting or publication requirement.
